Nine out of ten U.S. farms are considered "family farms," and for mother-daughter farming team Melinda and Maggie Wilder, the family farm is built around their relationship, supportive partners, immediate family members and a growing community of customers, neighbors and friends of Wolf Gap Gardens. Since 2020, this family farm has offered certified organic vegetables, herbs, flowers and value-added products at the Madison County Farmers Market and through a small, local Community Supported Agriculture (CSA) program. They delight in knowing many of their customers and build their product offerings around the community's feedback and requests.

Their farm business was launched in 2020 after a couple of years of exploring the market, readying the land and identifying resources and support available to small-scale Kentucky farmers. Recently retired from the role as Director of the Division of Natural Areas for Eastern Kentucky University, Melinda brought an understanding of grant-writing, people management and ecology from her career in higher education and natural resources. Maggie brought a wealth of experience in permaculture, organic farming and crop management from a career path that carried her to Washington, Ethiopia, Alaska and Virginia. Between the two of them, they hold complementary skills, experiences and interests that allow them to build their business and to support each other with a healthy work-life balance.

In their fifth year serving the community from their market farm, Maggie and Melinda are hosting a Farmer Field Day at Wolf Gap Gardens to share their teamwork approach, crop production, infrastructure and lessons learned. Read on for details and registration information.



Farmer Field Day: Building a Small-Scale Family Farm One Year at a Time

Wolf Gap Gardens, Berea KY -- July 9, 2024 -- 9 am - 12 pm ET

Launching a small vegetable farm requires much more than keeping the crops healthy: recordkeeping, finances, marketing, ongoing learning and countless decisions can overwhelm farmers in the early years. Melinda and Maggie Wilder of Wolf Gap Gardens in Madison County make the process appear smooth and enjoyable. This mother-daughter team launched their certified organic* vegetable production in 2020 on 1/2-acre, adding infrastructure and evolving their crop and product offerings on a consistent and intentional scale. Join this Field Day to visit their DIY greenhouse and high tunnel with rainwater catchment, walk through their summer field crops and rotational cover crops, explore their post-harvest wash-pack area and cold storage. Hear their success stories of securing financial assistance, developing value-added products and dividing their labor to fit their individual skills and experiences, as well as their off-farm lives. Maggie and Melinda will highlight the production tools they use on their human-powered farm; explain the crop fertility they implement with cover crops, nutrient management and reduced off-farm inputs and share their whole-farm management and planning activities outside of their vegetable production. Finally, the Wilders will share their farm's certification process and journey working with both the Kentucky Department of Agriculture and the Real Organic Project.

Reflections on June Field Days

Reduced Tillage, Cover Crops and Crop Rotations - June 4 Field Day at Lazy Eight Stock Farm

"Sometimes our experiments fail, but we won't improve if we don't try new things." Putting this into practice, farming trial and error has allowed Bryce Baumann and his family to improve their systems at Lazy Eight Stock Farm - expanding their crop production while minimizing disturbance to the soil, building soil health and organic matter, diminishing the use of plastic mulch and reducing the workload on the farm crew. Bryce shared this lesson, his system successes and a handful of cautionary tales at this June Field Day. Through their participation in OAK's Climate Smart Project, Lazy Eight Stock Farm has committed to continuing the experimentation and implementation of on-farm conservation practices. Whether it's letting go of crops that require extra time and space or longheld markets and management practices that no longer fit the family's goals, whole-farm planning has taken on a new energy for Foxfire Farm. Stewarded since 1991 by Aaron's parents, the farm has been in Aaron and Irina's hands since 2021. While they still maintain the organic certification and commitment to land stewardship that the Lange farm has always held, Aaron and Irina have introduced new practices, markets and efficiencies to make the farm their own. Organic Certification Cost Share Program

Organic Certification Cost Share Program (OCCSP) is available for operations submitting applications or renewing certification. OCCSP provides cost share assistance to producers and handlers of agricultural products who are obtaining or renewing their certification under the National Organic Program (NOP). Certified operations may receive up to 75 percent of their certification costs paid during the program year, not to exceed \$750 per certification scope. The deadline to apply is October 31, 2024. Some certifiers process cost share requests through the certification application, others do not. If your certifier does not process certification cost share then you can apply for cost share through your local USDA Farm Services Agency office. County Committee Elections

Farm Service Agency county committees are a critical component of the day-to-day operations of FSA and allow grassroots input and location administration of federal farm programs. Nationwide, more than 7,700 dedicated members of the agricultural community serve on FSA county committees. The committees are made up of three to 11 members who serve three-year terms. Elections occur each year in certain Local Administrative Areas (LAA). LAAs are elective areas for FSA committees in a single county or multi-county jurisdiction. This may include LAAs that are focused on an urban or suburban area.

USDA Commits Greater Conservation Assistance for Producers Transitioning to Organic Production On April 10, 2023, the U.S. Department of Agriculture (USDA) announced details about its \$75 million investment in conservation assistance for producers transitioning to organic production. The Natural Resources Conservation Service (NRCS) is dedicating financial and technical assistance to a new organic management standard and partnering with new organic technical experts to increase staff capacity and expertise. NRCS will dedicate \$70 million to assist producers with a new organic management standard under the Environmental Quality Incentives Program (EQIP). This program is for farmers who are beginning or in the process of transitioning to organic certification. OAK is in conversation with NRCS Kentucky and will work to communicate with farmers about the opportunity to apply for this new Organic Management Practice when it is available. \$1 Billion Available to Help Farmers Invest in Renewable Energy

U.S. Department of Agriculture (USDA) Secretary Tom Vilsack announced that USDA is accepting applications starting on April 1 for \$1 billion in grants to help agricultural producers and rural small businesses invest in renewable energy systems and make energy-efficiency improvements. USDA is making the \$1 billion in grants available under the Rural Energy for America Program (REAP), with funding from President Biden's landmark Inflation Reduction Act, the nation's largest-ever investment in combating the climate crisis. Silvopasture and Forest Farming Support / Funds Available

The Catalyzing Agroforestry Grant Program is focused on implementing silvopastures and forest farming practices through direct support payments and will assist producers in designing appropriate projects using technical assistance and science-based planning strategies. The ultimate goal of the effort is to increase ecosystem sustainability and diversity by scaling up agroforestry practices. The Appalachian Beginning Forest Farming Coalition (ABFFC) project will provide up to \$1500/acre for silvopasture implementation and up to \$1000/quarter acre for forest farming implementation depending on project scale and scope. To enhance shared learning, producers who receive support will share successes and lessons-learned with their peers and other interested stakeholders. Minority, female, Indigenous, LGBTQ+, and/or socially disadvantaged farmers are highly encouraged to apply. https://www.appalachianforestfarmers.org/emef

KSU Small Scale Farm Grant

Deadline: The 1st day of every other month

Funding Amount: Up to \$5,000 for farmers, \$15,000 for groups benefiting multiple farmers Eligible Entities: Kentucky farmers and Kentucky agriculture groups including farmers markets

Overview: The KSU Small Scale Farm Grant is designed with the small operation farmer in mind. This grant application is relatively simple to complete and the funds can be used to purchase needed equipment related to the proposed project. To qualify, applicants must be producing a value-added product, be an organic farmer, and/or be an aquatic farmer. Farmers markets are often eligible. Previously approved projects have included canning equipment, a walk-in cooler, a water line to a hoop house, a root cellar, a cool-bot for vegetables, and a trailer for keeping meat cool and recently added farmer education assistance with a maximum of \$500.

Kentucky Proud Promotional Grant

Deadline: On-going

Funding Amount: Up to 10% annual gross farm income, max at \$8,000 per year; \$1 for \$1 match

Overview: The Kentucky Proud Promotional Grant is a cost share program to help Kentucky farmers and agribusinesses pay for advertising and marketing expenses. The award amount is based on 10% of direct farm impact; for a farmer it would be 10% of their total farm gross sales. The applicant must be

a registered member of Kentucky Proud to apply and use the Kentucky Proud logo/brand in marketing efforts paid for with program funds. Examples of fundable items include TV ads, radio ads, web expenses, hats, t-shirts, demos, sampling, labels, packaging, tradeshows, UPC, and bar codes. This is a great program that helps promote our local farms!

ON-Farm Energy Efficiency Incentives Program

Deadline: Applications are accepted year round

Funding Amounts: 50% cost share - up to a \$10,000 incentive, plus \$150 for an approved third party energy audit

Eligible Entities: Kentucky farmers with a gross farm income of at least \$25,000

Overview: The Kentucky Agricultural Development Fund offers an On-Farm Energy Efficiency Program to help Kentucky farmers with energy projects. These cost share funds are available to increase on farm energy efficiency and to support renewable fuel production projects. The applicant is required to have a third party energy audit completed. This program can be combined with the USDA-NRCS Rural Energy for America Program (REAP) to get up to 75% of a total project cost covered.
